In conformity with EPA's request, the permit has been re-drafted with twice weekly monitoring frequencies for total nitrogen species and total phosphorous.

No other changes are proposed relative to the original draft permit.

I am sending this comment on behalf of Jen Fulton who is out of the office today. Apologies for the delay in getting this to you.

According to our Memorandum of Agreement, the Environmental Protection Agency (EPA) Region 3 has received the draft National Pollutant Discharge Elimination System (NPDES) permit for:

Springfield Township Hollow Creek STP
NPDES Number: PA0086860
EPA Received: June 13, 2025
30-day response due date: July 13, 2025

This is a minor permit that discharges to Unnamed Tributary to East Branch Codorus Creek and is a significant Chesapeake Bay discharger. EPA has chosen to perform a limited review of the draft permit based on the wasteload allocation requirements of the Chesapeake Bay Watershed TMDL. EPA has completed its review and offers the following comment:

1. This facility is considered a significant Chesapeake Bay discharger. Page 15 of PADEP's Phase 3 WIP Supplement provides that the monitoring frequencies for total nitrogen species and total phosphorous for significant Chesapeake Bay dischargers should be twice per week.
