**Summary of Review**

Scott Wellar has submitted an application for an NPDES permit for a proposed Single Residence Sewage Treatment Plant (SRSTP) to serve an existing home currently served by a malfunctioning septic system. The discharge is subject to an individual NPDES permit due to the treatment system not being one prescribed in the Department's Small Flow Treatment Facilities manual.

A WQM application for the associated treatment system has been received and will be issued with the final NPDES permit.

Act 537 Planning for the proposed treatment and discharge was approved by the Department in a May 19, 2021 letter.

A map of the discharge location is attached.

Public Participation

DEP will publish notice of the receipt of the NPDES permit application and a tentative decision to issue the individual NPDES permit in the *Pennsylvania Bulletin* in accordance with 25 Pa. Code § 92a.82. Upon publication in the *Pennsylvania Bulletin*, DEP will accept written comments from interested persons for a 30-day period (which may be extended for one additional 15-day period at DEP's discretion), which will be considered in making a final decision on the application. Any person may request or petition for a public hearing with respect to the application. A public hearing may be held if DEP determines that there is significant public interest in holding a hearing. If a hearing is held, notice of the hearing will be published in the *Pennsylvania Bulletin* at least 30 days prior to the hearing and in at least one newspaper of general circulation within the geographical area of the discharge.

Treatment Facility
The treatment facility, as proposed under WQM permit application No. 1421402 will consist of an EcoFlo Model EC7-500-P-G/P-Pack Coco Filter- system with integrated UV disinfection system.

Compliance History
A query in WMS found no open violations in eFACTS for Scott Wellar.

**Proposed Effluent Limitations and Monitoring Requirements**

The limitations and monitoring requirements specified below are proposed for the draft permit, and reflect the most stringent limitations amongst technology, water quality and BPJ. Instantaneous Maximum (IMAX) limits are determined using multipliers of 2 (conventional pollutants) or 2.5 (toxic pollutants). Sample frequencies and types are derived from the "NPDES Permit Writer's Manual" (362-0400-001), SOPs and/or BPJ.
