Dear Mr. Hoffman:

Your NPDES permit is enclosed. Please read the permit carefully. The permit expires on the date identified on page 1 of the permit. A renewal application must be submitted to this office 180 days prior to the permit expiration date, if operation is expected to continue past the expiration date of the permit.

Please study the permit carefully and direct any questions to this office. Particular attention should be devoted to Part A (Effluent Limitations, Self-Monitoring and Record Keeping Requirements) and the Special Permit Requirements in Part C of the permit.

We have included the following reporting and self-inspection forms for your use:

- Annual Report – complete this report for each calendar period and submit the report to DEP by February 15 of each year.
- CAFO Non-Compliance Discharge Report Form – complete this form and submit it to DEP within 5 days of any pollution incident at your operation. The form should be submitted to DEP only in the event of a pollution incident.
- Mortality Management for CAFOs – complete this form annually to document mortality management at your operation and retain on-site for 5 years in accordance with the permit.
- Manure Exportation Report – complete this form as manure is exported off the farm, even if you are managing the application of manure. Retain these forms on-site for 5 years and submit them to the Department within 15 days following the end of each calendar quarter.

- Self-Inspection Report – complete this form to document manure spreader inspections, weather conditions during manure application events, inspections of water lines, and corrective actions taken. Retain these forms on-site for 5 years and submit them to the Department within 15 days following the end of each calendar quarter.
- Other Self-Inspection Reports – if additional Self-Inspection Reports are attached to the permit (to document manure storage facility inspections or other self-inspection activities), complete the forms, retain them on-site for 5 years and submit them to the Department within 15 days following the end of each calendar quarter.

Routine self-inspections must be conducted no less than once every week in accordance with the permit, though more frequent self-inspections are recommended.

Please note that exceeding the Animal Equivalent Units (AEUs) allowed in the Nutrient Management Plan (NMP) is a violation of the permit. You must notify DEP in writing of any proposed change in AEUs greater than ten percent (10%) of the number of AEUs listed in the NMP and shall describe the proposed changes. This notification must be submitted at least 45 days prior to implementing the proposed change unless a shorter period of time is approved by the Department in writing. A proposed increase in the AEUs managed on the facility may require an amendment to the permit. Any permit amendment or NMP amendment required for a proposed increase in AEUs must be approved before the animal population is increased.

Any person aggrieved by this action may appeal, pursuant to Section 4 of the Environmental Hearing Board Act, 35 P.S. Section 7514, and the Administrative Agency Law, 2 Pa.C.S. Chapter 5A, to the Environmental Hearing Board, Second Floor, Rachel Carson State Office Building, 400 Market Street, P.O. Box 8457, Harrisburg, PA 17105-8457, 717.787.3483. TDD users may contact the Board through the Pennsylvania Relay Service, 800.654.5984. Appeals must be filed with the Environmental Hearing Board within 30 days of receipt of written notice of this action unless the appropriate statute provides a different time period. Copies of the appeal form and the Board's rules of practice and procedure may be obtained from the Board. The appeal form and the Board's rules of practice and procedure are also available in braille or on audiotape from the Secretary to the Board at 717.787.3483. This paragraph does not, in and of itself, create any right of appeal beyond that permitted by applicable statutes and decisional law.
