Summary of Review

This permit is being issued to approve the construction and operation of a single resident sewage treatment plant (SRSTP) consisting of:

- Singulair Bio-Kinetic Model 960 with 500-gallon treatment tank
- Hydro-Kinetic Bio-Film Reactor
- Model AT 1500 UV disinfection unit with 600-gallon dosing chamber



Associated WQM Permit No. 6321400 is also pending issuance upon approval from the department.

Per current policy, effluent limitations and monitoring requirements listed on page 4 of this Fact Sheet, at a minimum, will be established for individual SRSTP permit renewals. The limitations reflect the most stringent limitations amongst technology, water quality and BPJ. Instantaneous Maximum (IMAX) limits are determined using multipliers of 2 (conventional pollutants) or 2.5 (toxic pollutants). Sample frequencies and types are derived from the "NPDES Permit Writer's Manual" (362-0400-001), SOPs and/or BPJ.

Sewage discharges with design flows < 2,000 gpd do not require monitoring for Total Nitrogen and Total Phosphorus in new and reissued permits.

Technology-based effluent limits for pH will be imposed based upon State Regulation 95.2(1).

Ultraviolet (UV) disinfection is used therefore Total Residual Chlorine (TRC) limits are not applicable. Current policy does not require SFTFs to monitor for UV Intensity.

Summary of Review

Sewage discharges with design flows < 2,000 gpd are not required to monitor for Ammonia-Nitrogen, Total Nitrogen, and Total Phosphorus in new and reissued permits.

Act 537 planning for this facility was approved on March 4, 2021.

Public Participation

DEP will publish notice of the receipt of the NPDES permit application and a tentative decision to issue the individual NPDES permit in the *Pennsylvania Bulletin* in accordance with 25 Pa. Code § 92a.82. Upon publication in the *Pennsylvania Bulletin*, DEP will accept written comments from interested persons for a 30-day period (which may be extended for one additional 15-day period at DEP's discretion), which will be considered in making a final decision on the application. Any person may request or petition for a public hearing with respect to the application. A public hearing may be held if DEP determines that there is significant public interest in holding a hearing. If a hearing is held, notice of the hearing will be published in the *Pennsylvania Bulletin* at least 30 days prior to the hearing and in at least one newspaper of general circulation within the geographical area of the discharge.
