**Summary of Review**

This is a new discharge for an existing 4-bedroom home and one camper to a repair of an existing malfunctioning on-lot system.

Act 14 – Proof of Notification was submitted and received.

Proposed treatment will consist of (WQM Permit No. 2020406): A 1500-gallon dual chambered concrete septic tank followed by a 500-gallon septic tank (from an existing dosing tank), followed by a 1,250 single-compartment septic tank, Premier Tech EC7 Coco Filter unit and an existing UV unit to be relocated.

The EPA Waiver is in effect.

There are no open violations in WMS for the subject Client ID (283778) as of 8/13/2021.

Public Participation

DEP will publish notice of the receipt of the NPDES permit application and a tentative decision to issue the individual NPDES permit in the *Pennsylvania Bulletin* in accordance with 25 Pa. Code § 92a.82. Upon publication in the *Pennsylvania Bulletin*, DEP will accept written comments from interested persons for a 30-day period (which may be extended for one additional 15-day period at DEP's discretion), which will be considered in making a final decision on the application. Any person may request or petition for a public hearing with respect to the application. A public hearing may be held if DEP determines that there is significant public interest in holding a hearing. If a hearing is held, notice of the hearing will be published in the *Pennsylvania Bulletin* at least 30 days prior to the hearing and in at least one newspaper of general circulation within the geographical area of the discharge.

Changes Since Last Permit Issuance: N/A – This is a proposed discharge (Planning was approved on May 29, 2021).

Other Comments:

This SRSTP was designed where applicable in accordance with the SFTF Manual, but it does not qualify for the PAG-04 General Permit due to the use of a Coco Filter. The proposed discharge is to resolve a repair of a malfunctioning on-lot system.

The Coco Filter unit is reportedly capable of meeting CBOD5 averages of 10 mg/l and TSS averages of 10 mg/l.

In accordance with the SOP, no water quality modeling was performed since this is a SRSTP.

**Proposed Effluent Limitations and Monitoring Requirements**

The limitations and monitoring requirements specified below are proposed for the draft permit, and reflect the most stringent limitations amongst technology, water quality and BPJ. Instantaneous Maximum (IMAX) limits are determined using multipliers of 2 (conventional pollutants) or 2.5 (toxic pollutants). Sample frequencies and types are derived from the "NPDES Permit Writer's Manual" (362-0400-001), SOPs and/or BPJ.
