Purpose of Application	<u>NPDES Permit renewal for discharge of stormwater associated with industrial activity.</u>		

Summary of Review

The applicant is requesting renewal of their NPDES Permit to discharge stormwater associated with Industrial Activity to Little Bushkill Creek, which is a HQ-CWF, MF (High Quality – Cold Water Fishes, Migratory Fishes) designated receiving stream to State Water Plan Basin 1-F (Jacoby – Bushkill Creek). As per the Department's current existing use list, this receiving stream does not have an existing use classification that is more protective than its designated use.

The permit application indicates the facility is categorized by SIC code 5015 (Wholesale Trade – Motor Vehicle Parts, Used). The Pollution Prevention Plan that was provided with the application indicates the facility is also categorized by SIC code 5093 (Whole Trade – Scrap and Waste Materials). The facility falls under the Appendix O and P monitoring requirements of the PAG-03 General Permit.

This site falls under the conditions of Appendix O and Appendix P of the PAG-03 General Permit. These 2 appendices share the following benchmark requirements: 1) Total Suspended Solids Limit of 100 mg/L. 2) Chemical Oxygen Demand Limit of 120 mg/L. 3) Oil and Grease Limit of 30 mg/L. These values are IMAX limitations and should be sampled semi-annually via Grab sample. 4) Total Nitrogen is a limit required by calculation. 5) Total Phosphorous as a reported daily maximum 6) Total Aluminum as a reported daily maximum 7) Total Lead as a reported daily maximum. The minimum measurement frequency is semi-annually. Total Phosphorous, Total Aluminum and Total Lead will be sampled via Grab sample.

Appendix O additionally requires semi-annual monitoring of the following pollutants: 1) Total Iron reported as a daily maximum which will be sampled via Grab sample.

Appendix P additionally requires semi-annual monitoring of the following pollutants: 1) Total Copper reported as a daily maximum 2) Total Zinc reported as a daily maximum. These pollutants will be sampled via Grab sample.

Summary of Review

From the previous permit, PAS602203, the drainage area was 209,088 ft². As of the August 13, 2025 application, the drainage area was reported as 1,380,852 ft² as developed from StreamStats. The site is reported to experience significant run-on. Therefore, the StreamStats area is more representative of the site and will be used in PA0276995.

PPC Plan implementation and completion of an annual inspection and compliance evaluation are required under permit.

A Water Management System Inspection query indicated on March 21, 2024 a Routine/Partial Inspection was performed.

The previously issued permit has an expiration date of January 31, 2026. The application was received on August 13, 2025.

There are no open violations that would warrant withholding this permit.

Public Participation

DEP will publish notice of the receipt of the NPDES permit application and a tentative decision to issue the individual NPDES permit in the *Pennsylvania Bulletin* in accordance with 25 Pa. Code § 92a.82. Upon publication in the *Pennsylvania Bulletin*, DEP will accept written comments from interested persons for a 30-day period (which may be extended for one additional 15-day period at DEP's discretion), which will be considered in making a final decision on the application. Any person may request or petition for a public hearing with respect to the application. A public hearing may be held if DEP determines that there is significant public interest in holding a hearing. If a hearing is held, notice of the hearing will be published in the *Pennsylvania Bulletin* at least 30 days prior to the hearing and in at least one newspaper of general circulation within the geographical area of the discharge.
