Summary of Review

The project involves the installation of a new single residence sewage treatment plant to replace an existing malfunctioning onlot system.

Act 537 Planning was approved on September 26, 2019.

Proposed treatment will consist of: A Premier Tech EC&-600-P-P/G Pack Coco filter unit consisting of a septic tank, coco filter, and UV disinfection unit.

The proposed system is to replace a failing onlot system at the existing residential dwelling thus, protecting the quality of Buffalo Creek. The proposed discharge is not expected to adversely effect the High Quality waters in the Buffalo Creek watershed considering the expected effluent quality and size of the proposed discharge.

Public Participation

DEP will publish notice of the receipt of the NPDES permit application and a tentative decision to issue the individual NPDES permit in the *Pennsylvania Bulletin* in accordance with 25 Pa. Code § 92a.82. Upon publication in the *Pennsylvania Bulletin*, DEP will accept written comments from interested persons for a 30-day period (which may be extended for one additional 15-day period at DEP's discretion), which will be considered in making a final decision on the application. Any person may request or petition for a public hearing with respect to the application. A public hearing may be held if DEP determines that there is significant public interest in holding a hearing. If a hearing is held, notice of the hearing will be published in the *Pennsylvania Bulletin* at least 30 days prior to the hearing and in at least one newspaper of general circulation within the geographical area of the discharge.
