### Summary of Review

The permittee is applying for reissuance of Individual Permit **PA0288250** that expired on July 1, 2025. This is a discharge into stream channel - Trib 62586 To Elk Creek. The average daily flow is projected to be 400 GPD.

Act 14 notifications were submitted and received.

The existing facility under (WQM Permit No. 2520407) issued on November 16, 2021 consist of: A 1,000-gallon concrete septic tank followed by a Premier Tech EC7-500-C-PDV Ecoflo Coco Filter biofiltration system with integrated DiUV ultraviolet disinfection.

AMR was received and appears to operate as designed.

There are no open violations in WMS for the subject Client ID (**363153**) as of July 2, 2025.

#### Public Participation

DEP will publish notice of the receipt of the NPDES permit application and a tentative decision to issue the individual NPDES permit in the *Pennsylvania Bulletin* in accordance with 25 Pa. Code § 92a.82. Upon publication in the *Pennsylvania Bulletin*, DEP will accept written comments from interested persons for a 30-day period (which may be extended for one additional 15-day period at DEP's discretion), which will be considered in making a final decision on the application. Any person may request or petition for a public hearing with respect to the application. A public hearing may be held if DEP determines that there is significant public interest in holding a hearing. If a hearing is held, notice of the hearing will be published in the *Pennsylvania Bulletin* at least 30 days prior to the hearing and in at least one newspaper of general circulation within the geographical area of the discharge.

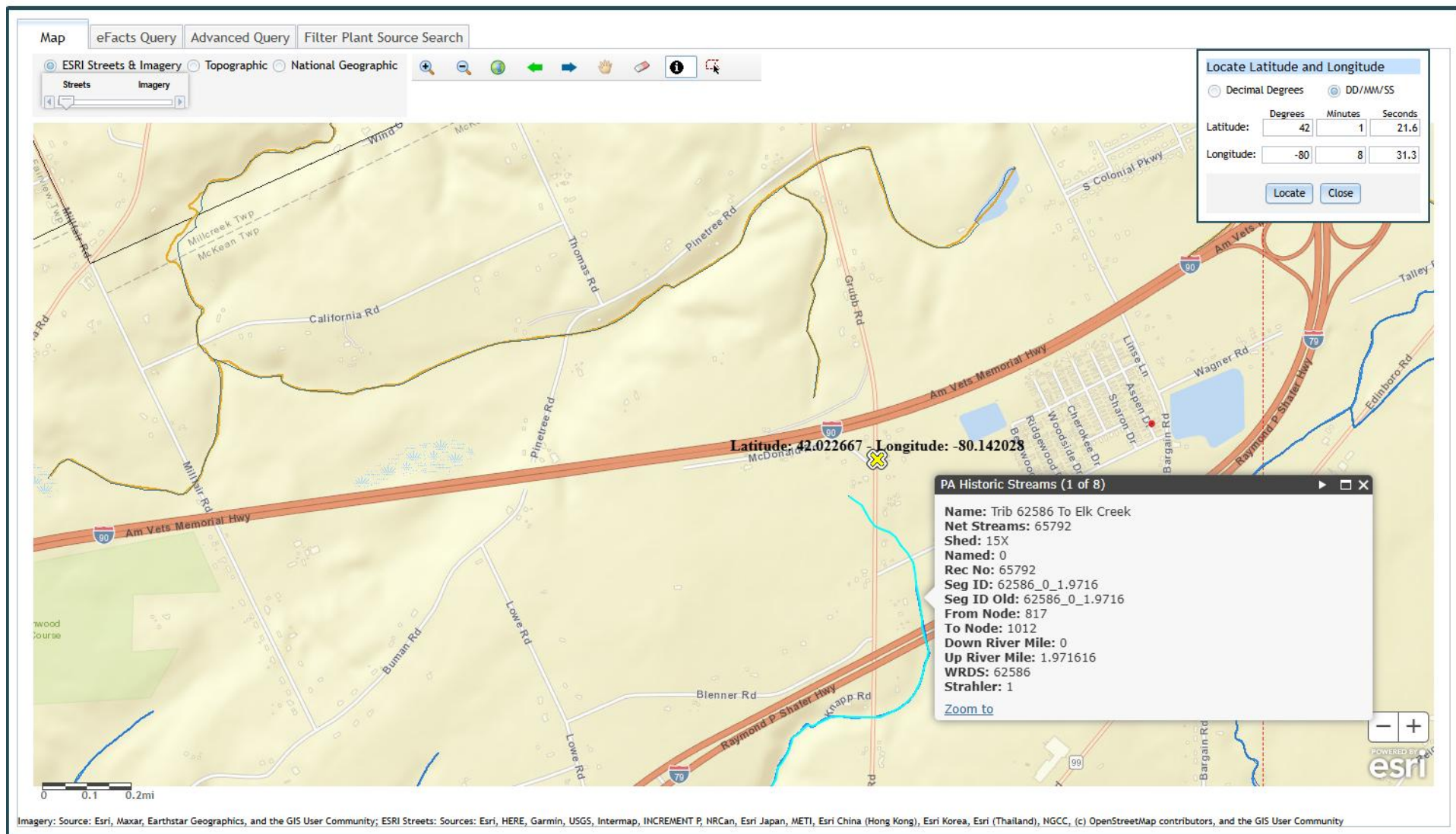
