**Summary of Review**

The permittee is applying for reissuance of Individual Permit **PA0288357** that expired June 30, 2025. This is a discharge into stream channel - Trib 62328 To Lake Erie. The average daily flow is projected to be 400 GPD.

The existing facility consists of (WQM Permit No. 2520410) A Premier Tech EC7-600-P-P PACK Coco Filter Unit containing a septic tank, coco filter, and ultraviolet disinfection.

Act 14 notifications were submitted and received.

AMR was submitted and the system appears to be operational.

There is only one open violations in WMS for the subject Client ID (364102) as of August 27, 2025. Violation: NPDES - Failure to pay annual fee.

**Public Participation**

DEP will publish notice of the receipt of the NPDES permit application and a tentative decision to issue the individual NPDES permit in the *Pennsylvania Bulletin* in accordance with 25 Pa. Code § 92a.82. Upon publication in the *Pennsylvania Bulletin*, DEP will accept written comments from interested persons for a 30-day period (which may be extended for one additional 15-day period at DEP's discretion), which will be considered in making a final decision on the application. Any person may request or petition for a public hearing with respect to the application. A public hearing may be held if DEP determines that there is significant public interest in holding a hearing. If a hearing is held, notice of the hearing will be published in the *Pennsylvania Bulletin* at least 30 days prior to the hearing and in at least one newspaper of general circulation within the geographical area of the discharge.

**Proposed Effluent Limitations and Monitoring Requirements**

The limitations and monitoring requirements specified below are proposed for the draft permit, and reflect the most stringent limitations amongst technology, water quality and BPJ. Instantaneous Maximum (IMAX) limits are determined using multipliers of 2 (conventional pollutants) or 2.5 (toxic pollutants). Sample frequencies and types are derived from the "NPDES Permit Writer's Manual" (362-0400-001), SOPs and/or BPJ.






