Internal Review and Recommendations

Smithfield Township is a municipality in Monroe County. The population is approximately 8,042. Referencing the 2010 U.S. Census Bureau Urbanized Area GIS layer, about 50% of the geographic area is considered to be urbanized. No significant changes within the municipality have been noted.

The municipality shall continue to implement the Pollutant Reduction Plan (PRP) if not completed.

Public Participation

DEP will publish notice of the receipt of the NPDES permit application and a tentative decision to issue the individual NPDES permit in the *Pennsylvania Bulletin* in accordance with 25 Pa. Code § 92a.82. Upon publication in the *Pennsylvania Bulletin*, DEP will accept written comments from interested persons for a 30-day period (which may be extended for one additional 15-day period at DEP's discretion), which will be considered in making a final decision on the application. Any person may request or petition for a public hearing with respect to the application. A public hearing may be held if DEP determines that there is significant public interest in holding a hearing. If a hearing is held, notice of the hearing will be published in the *Pennsylvania Bulletin* at least 30 days prior to the hearing and in at least one newspaper of general circulation within the geographical area of the discharge.
