Internal Review and Recommendations

- A late Individual MS4 NPDES Permit renewal application from Mt. Pleasant Township was received by DEP on 10/10/23
- The Township provided the furthest downstream outfalls for the six streams that stormwater is discharged to
 - Outfall 031 to Boyer Run which has a 25 PA Code Chapter 93 Warm Water Fishes designation and is not impaired at the point of discharge, but is impaired for acid mine drainage (AMD) metals downstream
 - Outfall 004 to Shupe Run which has a 25 PA Code Chapter 93 Warm Water Fishes designation and is impaired for siltation from highway/road/bridge runoff (non-construction related)
 - Outfall 043 to Sewickley Creek which has a 25 PA Code Chapter 93 High Quality Cold Water Fishes designation and is impaired for pathogens from an unknown source, pH from AMD, and siltation from agriculture
 - Outfall 046 to Jacobs Creek which has a 25 PA Code Chapter 93 Warm Water Fishes designation and is unimpaired
 - Outfall 012 to Tributary 37964 to Brush Run which has a 25 PA Code Chapter 93 Cold Water Fishes designation and is unimpaired
 - Outfall 024 to Tributary 37776 to Welty Run which has a 25 PA Code Chapter 93 High Quality Cold Water Fishes designation and is unimpaired (source: 2024 Integrated Report)
- The MS4 currently has no open violations and last had a compliance evaluation inspection on 7/19/2021 with three violations noted that have since been resolved

Internal Review and Recommendations

- 92A.32(A): NPDES MS4 – Failure to submit an MS4 Periodic Report. The Annual Stormwater Progress Report for 2020 was not submitted to the Department by the deadline. Annual Stormwater Progress Reports are to be submitted to the Department by September 30th yearly.
 - MS4-MCM1: Failure to develop a written Public Education and Outreach Program (PEOP).
 - MS4-MCM2: Failure to develop a written Public Involvement and Participation Program (PIPP).
- Permit renewal is recommended.

Public Participation

DEP will publish notice of the receipt of the NPDES permit application and a tentative decision to issue the individual NPDES permit in the *Pennsylvania Bulletin* in accordance with 25 Pa. Code § 92a.82. Upon publication in the *Pennsylvania Bulletin*, DEP will accept written comments from interested persons for a 30-day period (which may be extended for one additional 15-day period at DEP's discretion), which will be considered in making a final decision on the application. Any person may request or petition for a public hearing with respect to the application. A public hearing may be held if DEP determines that there is significant public interest in holding a hearing. If a hearing is held, notice of the hearing will be published in the *Pennsylvania Bulletin* at least 30 days prior to the hearing and in at least one newspaper of general circulation within the geographical area of the discharge.
