# 4. FIRST AID MEASURES

Inhalation: If inhaled, remove to fresh air. Get medical attention if symptoms occur.

Most important symptoms and effects, both acute and delayed: Causes serious eye irritation.

#### 5. FIRE FIGHTING MEASURES

Suitable extinguishing media: CO2, alcohol-resistant foam, dry chemical, or water spray.

Specific hazards during fire-fighting: Exposure to combustion products may be a hazard to health.

Hazardous combustion products: Carbon oxides, silicon oxides, formaldehyde, and metal oxides.

**Specific extinguishing methods:** Use extinguishing measures that are appropriate to local circumstances and the surrounding environment. Use water spray to cool unopened containers. Remove undamaged containers from fire if it is safe to do so. Evacuate area.

**Special protective equipment for fire-fighters:** In the event of fire, wear self-contained breathing apparatus. Use personal protective equipment.

#### 6. ACCIDENTAL RELEASE MEASURES

**Personal precautions, protective equipment and emergency procedures:** Use personal protective equipment. Follow safe handling advice and personal protective equipment recommendations.

**Environmental precautions:** Discharge into the environment must be avoided. Prevent further leakage or spillage if safe to do so. Prevent spreading over a wide area (e.g. by containment of oil barriers). Retain and dispose of contaminated wash water. Local authorities should be advised if significant spillages cannot be contained.

Methods and materials for containment and cleaning up: Soak up with inert absorbent material. For large spills, provide diking or other appropriate containment to keep material from spreading. If diked material can be pumped, store recovered material in appropriate container. Clean up remaining materials from spill with suitable absorbent. #### 7. HANDLING AND STORAGE

Local/Total ventilation: Use only with adequate ventilation.

**Advice on safe handling:** Avoid inhalation of vapor or mist. Do not swallow. Do not get in eyes. Avoid prolonged or repeated contact with skin. Handle in accordance with good industrial hygiene and safety practice. Take care to prevent spills, waste and minimize release to the environment.

**Conditions for safe storage:** Keep in properly labeled containers. Store in accordance with the particular national regulations.

Materials to avoid: Do not store with the following product types: Strong oxidizing agents.

#### 8. EXPOSURE CONTROLS / PERSONAL PROTECTION

**Engineering measures:** Processing may form hazardous compounds (see section 10). Ensure adequate ventilation, especially in confined areas. Minimize workplace exposure concentrations.

#### **Personal Protective Equipment**

Respiratory protection: General and local exhaust ventilation is recommended to maintain vapor exposures below recommended limits. Where concentrations are above recommended limits or are unknown, appropriate respiratory protection should be worn. Follow OSHA respirator regulations (29 CFR 1910.134) and use NIOSH/MSHA approved respirators. Protection provided by air purifying respirators against exposure to any hazardous chemical is limited. Use positive pressure air supplied respirator if there is any potential for uncontrolled release, exposure levels are unknown, or any other circumstance where air purifying respirators may not provide adequate protection.

Hand protection material: Impervious gloves

**Remarks:** Choose gloves to protect hands against chemicals depending on the concentration specific to place of work. Breakthrough time is not determined for the product. Change gloves often! For special applications, we recommend clarifying the resistance to chemicals of the aforementioned protective gloves with the glove manufacturer. Wash hands before breaks and at the end of the workday.

Eye protection: Wear the following personal protective equipment: safety goggles.

**Skin and body protection:** Select appropriate protective clothing based on chemical resistance data and an assessment of the local exposure potential. Skin contact must be avoided by using impervious protective clothing (gloves, aprons, boots, etc).

**Hygiene measures:** Ensure that eye flushing and safety showers are located close to the working place. When using do not eat, drink, or smoke. Was contaminated clothing before re-use. These precautions are for room temperature handling. Use at elevated temperature or aerosol/spray applications may require added precautions.
