

NexGuard 22358 is formulated for maximum scale inhibition and minimizes corrosion for boilers operating at or below 600 psig (41barg) with moderate feedwater hardness and moderate feedwater oxygen.

Underfeed of NexGuard 22358 will result in higher maintenance costs and potential failures.
